The City of Beverly, Massachusetts, acting through the Beverly Regional Airport Commission, invites sealed bids for furnishing all labor and materials and performing all work in connection with a construction contract at the Beverly Regional Airport, Beverly, Massachusetts as follows:

PURCHASE SNOW REMOVAL EQUIPMENT (SRE) – CARRIER VEHICLE WITH SNOWPLOW BLADE; AND MATERIAL SPREADER

Procedures regarding bids and the selection of contractors shall be in conformity with the Massachusetts General Laws, Chapter 30, Section 39M, as amended to date. Sealed Bids for the General Contract must be delivered to the office of the Airport Manager 50 L.P. Henderson Road, Beverly, MA 01915 prior to 10:00 a.m., Eastern Daylight Savings Time, on Wednesday, February 19, 2025, at which time and place the bids will be publicly opened and read aloud. Bids received after the above time and date will be returned unopened.

The proposed work includes the purchase of new snow removal equipment consisting of a 12-foot snowplow blade, carrier vehicle and dry material spreader.

The General Bids shall be filed with the Owner at the location designated above, accompanied by a bid deposit in the form of a bid bond or a certified check, in the amount not less than five percent (5%) of the bid price for the Contract work. The bid security shall be made payable to the Beverly Regional Airport Commission.
